



- Two application cycles per year
- Reimbursement prioritization updated each cycle
- Next application cycle:
  - Opens August 1, 2023
  - Closes September 5, 2023

### Builder Next Steps – For **Any** Prioritized Project

- Whether Project is above or below the April 2023 funding line...
- Toho will agree to pay the Project reimbursement (upon Toho's standard project acceptance process) by Q2 of 2024, provided the following:
  - Toho approved design plans
  - Three (3) competitive contractor bids
  - Signed Line Extension Agreement <u>OR</u> Builder provides a written intent to execute a Line Extension Agreement
- Signed Line Extension Agreement or Written Intent must be in place by Monday, July 31st, 2023

#### Notice of Budget Availability for Toho Water CIAC Utility Line Extension Program Projects with Signed Agreement

#### Dear Developer:

The Toho Water Authority (Toho) has reviewed and discussed your concerns regarding budget availability for CIAC projects ranked underneath the budget availability line as shown in the latest Reimbursement Prioritization Table (April 2023). However, if your project can meet the following three (3) conditions by July 31, 2023, Toho will agree to pay your project reimbursement by the end of the second quarter of 2024 (provided construction is complete and passes Toho's standard project acceptance process):

- 1. obtain Toho approved design plans
- 2. acquire three (3) competitive quotes from Contractors
- sign a Utility Extension Agreement with Toho <u>OR</u> provide a signed letter of intent to execute the Utility Line Extension Agreement once provided by Toho


