

TOHO STRUCTURE RECORD RELEASE ACKNOWLEDGMENT

THIS ACKNOWLEDGMENT shall apply to the dissemination of any and all information, data and/or records concerning plans, blueprints, schematic drawings, locations and diagrams, including draft, preliminary and final formats, which may depict the location, layout and structural elements of Toho Water Authority ("TOHO") utility and other such facilities ("TOHO structures").

THE UNDERSIGNED acknowledges and understands that the requested TOHO structures described in the attached Exhibit "A" are exempt from review as public records under Chapter 119 and the State Constitution, and that by law such information may only be disclosed to the following:

- (1) Another governmental entity if disclosure is necessary for the receiving entity/individual to perform its duties and responsibilities;
- (2) A licensed architect, engineer or contractor who is performing work on or related to the requested TOHO structures described in the attached Exhibit "A"; or
- (3) Upon a showing of good cause before a court of competent jurisdiction.

ADDITIONALLY, the undersigned acknowledges that entities or person(s) receiving such information are statutorily required to maintain the exempt status of information. In other words, it is unlawful to obtain information concerning TOHO structures under false pretenses, and similarly, unlawful to share or otherwise disseminate such information concerning TOHO structures for any reason other than the lawful purposes under which it was obtained.

THE UNDERSIGNED HEREBY CERTIFIES AND AFFIRMS UNDER PENALTY OF PERJURY THE FOLLOWING:

1. The undersigned is or duly acts on behalf of the following authority (check each that applies):

- _____ A Governmental entity who must obtain information concerning TOHO structures to perform its duties and responsibilities.
- _____ A licensed architect, engineer, or contractor who is performing work on or related to the requested TOHO structures described in the attached Exhibit "A" (a license number or copy of license is required for file).
- _____ A person or entity who, after providing notice to TOHO, has shown good cause before a court of competent jurisdiction, and possesses an appropriate Order compelling review and copying of specific information concerning TOHO structures.

2. The undersigned understands, certifies, acknowledges and agrees that:

- (a) The undersigned is requesting information concerning TOHO structures for a legitimate purpose, which may include planning, connecting, installing, or repairing infrastructure near or related to TOHO structures;
- (b) Any and all persons receiving any information based upon the foregoing representations are required by law (and shall act to so inform in writing any third party who may properly use or share such information) to maintain the exempt status of the information provided;
- (c) Any and all information obtained does not carry with it any representation or certification, implied or express, of completeness, reliability or suitability for any purposes, or accuracy; that the recipient assumes all risks of reliance upon or use of such information; and
- (d) The undersigned, to the maximum extent permitted by law and on behalf of itself, and any other persons with whom the information is shared legitimately or otherwise, holds TOHO, its officials, officers, employees, agents, contractors and all other persons or entities affiliated with TOHO harmless from any loss, claim, demand, or responsibility for adverse consequence of any conceivable nature resulting from the use, accuracy, or reliance upon the information for any purpose, including but not limited to the information being erroneous, incomplete, incorrect, or inaccurate.
